satisfactory performance during probation period. These issues with the Approval of Govt. Vide Note # 36 dated. 22-06-2023.

## The Appointment is subject to the following conditions :-

- 1. The salary will be prepared from the date of his/her joining in the duty.
- 2. The appointment/regularization is purely temporary and may be terminated at any time by giving 1 (one) month notice in case if any given information furnished by the teacher proves to be false and if the teacher is found to have willfully suppressed any material fact he/she will be liable to be removed from service/discharged from probation and such other action may be taken by the Govt. as deemed fit.
- 3. If he/she wants to resign, he/she may do so after given 1(one) month notice or by surrendering 1(one)
- 4. The appointment/regularization of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- 5. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Govt. Medical Officer.
- 6. The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
- 7. After joining duty he/she will have to take Oath of an Allegiance of affirmation to the Constitution of India in the prescribed form.
