O R D E R

In pursuance of the administrative approval NO.SS-11011/29/2021-O/o SPD-SAMAGRA SHIKSHA/817-20 DTD.26/11/2021 Ms. Laksham Chamchang is hereby engaged as Resource Person (Hindi) on contractual basis against the resultant vacant post of Ms. Aroti Tabing in the fixed pay Rs. 26,453/- (Rupees Twenty-six thousand four hundred fifty-three) only with effect from the date of joining.

**The engagement is subject to the following conditions:-**

- a) The contract service has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract services period he/she is not entitle for medical reimbursement , winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc.
- d) The contract service have to report to his/her duties at the place of posting within 7(seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will be automatically be treated as cancelled.
- e) He/She is not entitled to subscribed GPF or CGEIS or other schemes during the period of contract services.
- f) No representation will be accepted for changing of posting place.
- g) The employee has to sign an agreement for contract engagement before receiving this order.
- h) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
- i) The contract service shall be terminated by the undersigned on receipt of substantive complaint.


