ORDER

No. ED.2/DSE/110/APT/2012: Miss Yam Saroh is hereby appointed temporarily to the post of Trained Graduate Teacher (Hindi) in the Pay Band-2 of Rs. 9300-34,800 + GP-Rs. 4600/- P.M. and other allowances as admissible under rules from time to time with effect from the date he / she actually reports for duties to the Principal, Govt. Higher Secondary School, Thrizino, West Kameng District, Arunachal Pradesh.

The appointment is made vice Smti Priya Chakraborty, Ex-JT (VRS).

- (2) The appointment is subject to the following conditions:-
- (i) The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining and his / her seniority will be fixed as per the over all merit.
  - (ii) The appointment is purely on temporary and may be terminated at any time by giving 1(one) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.
  - (iii) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
  - (iv) After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
  - (v) He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
  - (vi) The appointment is Subject to the Police Verification and he / she will dismissed from government service if any adverse report is there with immediate effect.
  - (vii) The Trained Graduate Teacher (JTs) who are posted to Higher Secondary School should teach Class XI & XII in their concerned subject till the sanction and posting of Post Graduate Teacher against the said schools.
  - (viii) He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of 3(three) years of service in the initial place of posting.
- Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
