ORDER

Miss Nyajum Talar is hereby appointed as Full Time Teachers (FTT) Social Science on contract basis in the fixed pay of ₹.20,000.00 (Rupees Twenty Thousand) only with effect from the date of joining in the concerned school up to 31/03/2024 against Centrally Sponsored Scheme of Samagra Shiksha, ISSE. She is posted at Netaji Subhash Chandra Bose Avasiya Vidyalaya, Dept.

This order issued as per administrative approval of the competent authority of Samagra Shiksha ISSE, Arunachal Pradesh, Itanagar vide Order File No. SS-11011/4/2021-O/o-SAMAGRA SHIKSHA Dated Itanagar the 20th March, 2023.

The engagement is subject to the following conditions:-

1. The contractual teacher has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
2. No Earned Leave is permissible except casual leave as per Central Civil Service Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period he/ she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
4. The contract teacher have to report his/ her duty at posting place within 07 (Seven) days from the date of joining in the office of concerned school, failing which his/ her appointment order will be treated as cancelled.
5. He/ She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
6. The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of Literacy in Arunachal Pradesh in addition to his/ her normal duties.
7. No representation will be accepted for change of posting place.
8. He/ She will have to undergo DIET training at concern DIET for training as and when call for.
9. The appointed teacher shall teach both Science and Math subjects.
10. The continuation and extension of the services of the appointed teacher contract at the end of a financial year shall be subject to the approval of the continuation of the Project (Samagra Shiksha) by MHRD, Govt. of India and the subsequent extension period will be subject to Satisfactory Performance of duty.
11. The appointed teacher shall be on the basis of 'No work No Pay'. Salaries shall be paid only for the academic session. No salary will be paid for vacation period.
12. The appointed teacher has to sign as agreement for contract engagement before receiving this engagement order.
13. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
