ORDER

Shri Karling Venia is hereby engaged as Part Time Teacher (Health & Physical Education) on contract basis in the fixed pay Rs. 10,000/- (Rupees Ten thousand) only with effect from the date of joining up to the financial year 2023-24 i.e, 31-03-2024 against Centrally Sponsored Scheme of Samagra Shiksha (ISSE) as per Govt. approval vide No.SS-11011/27/2021-SPD/1/174799 dtd. 26/10/2023. He is posted to NSCBV, Doka.

The engagement is subject to the following conditions: -

- The contract employee has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During contract service period, he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
- The second party shall be entitled for drawal of salary only for the financial year. Salaries for vacation period shall be drawn only when they are engaged in training and any other departmental engagement.
- The contract employee have to report for his/her duty at posting place within 7 (Seven) days from the date receipt of appointment order, failing which his/her engagement order will automatically be treated as cancelled.
- He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- No representation will be accepted for change of posting place.
- He/She will have to undergo for training as and when call for.
- The other terms and conditions of services which are not specified herein shall be governed by the relevant rules and order in forced time to time.
- The engaged employee has to sign an agreement and affidavit for contract engagement before receiving this engagement order.
