APPOINTMENT ORDER

Shri. Geki Darin is hereby appointed as Information and Communication Technology (ICT) Instructor on contract basis, at a fixed salary of Rs. 35,000/- (Rupees Fifteen Thousand) only with effect from the date of joining till the concerned period for a period of 10 months and Posted at Govt. Higher Sec. School, Itanagar. However, he can be re-employed subject to satisfactory of duty and allocation of funds under ICT recurring cost in the subsequent year by the MOE, Department of School Education and Literacy, Govt of India.

The appointment is subject to the terms and conditions of Contract signed between the District Project Officer, on behalf of State Project Director ISSE, Samagra Shiksha Itanagar and the incumbent.

The engagement is subject to the following conditions:

1. The incumbent shall enter into "Deed of Agreement" with the DDSE cum District Project Officer (DPO) before the issue of the formal Appointment order with 1-(one) day break in service every after 2-(two) months or 30 days to be incorporate in the deed of agreements in addition to the existing Deed of Agreements.
2. The incumbent has to report his/her duty at posting place within 7(seven) days from the date of Appointment, failing which his/her engagement order shall be automatically treated as cancelled.
3. No representation will be entertained for change of posting place.
4. No earned leave is permissible except casual leave in accordance with central civil service leave rules and per per terms and conditions in the agreement copy.
5. During contract service period he/she is not entitled for regular retirement, gratification, pension, special compensatory allowance, etc.
6. He/she is not entitled to submit for EPF or PF or any other schemes during the period of contract services.
7. The other terms and condition of service which are not specified shall be governed by the relevant rules and order in force at time to time.
8. The incumbent has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
