APPOINTMENT OF DPD

Shri. Gehji Darin is hereby appointed as Education and Communication Technology (ECT) Officer for a contract basis at a fixed salary of Rs. 35,000/- (Rupees Fifteen Thousand) only with effect from the date of issuing this concerned Circular for a period of 16 months and Posted at Govt. Higher Secondary School, Itanagar. However, he can be re-employed subject to satisfactory of duty and allocation of funds under ECT recurring cost in the subsequent year by the MoE, Department of School Education and Literacy, Govt. of India.

The appointment is subject to the terms and conditions of Contract signed between the District Project Officer, on behalf of State Project Director ISSE, Samagra Shiksha Mission and the appointee.

The engagement is subject to the following conditions:

- a. The incumbent shall enter into "Deed of Agreement" with the DPO cum District Project Officer (DPO) before the issue of the formal appointment order with 1-(one) day break in service every year.
- b. The incumbent has to report his/her duty of posting place within 7(seven) days from the date of appointment, failing which his/her engagement or fee shall be automatically treated as cancelled.
- c. No representation will be entertained for change of posting place.
- d. No annual leave is permissible except casual leave as per central civil service leave rules and its per ferme and conditions in the agreement copy.
- e. During contract services second best fee is paid to him/her if from further want within three days of leaving engagement of all necessary travel expenses of return fare, Leave travel money etc., special compensatory allowance etc.
- f. The state is not entitled to salary back of 2013 or 2014 or such other schemes during the period of contract services.
- g. The other terms and condition of service which are not described shall be governed by the relevant rules and order in force time to time.
- h. The incumbent has no right to claim for regular appointment regularization of the post after end of contract engagement.
