- (d) The appointment is subject to the police verification and He/She will be discharged from service with immediate effect if there is any adverse remarks against his/her in the police Report.

- (f) Four Copies of receipt passport size photograph duly ~~not~~ signed by the applicant.
- (g) The other terms and conditions which are not specified here would be governed by the rule and order that may in force from time to time.
