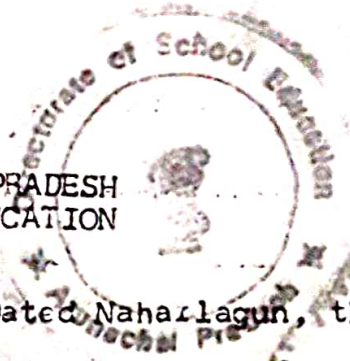

Henceforth, she will be known as Shri Marshall Borang for all purpose.

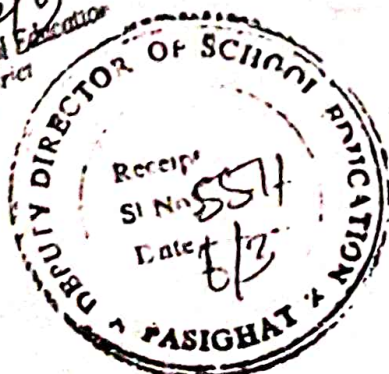
