- The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the concerned DDSE,s office failing which his/her engagement order will automatically be h) treated as cancelled. - The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also 1) bound to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any addition to his/ her normal duties.
