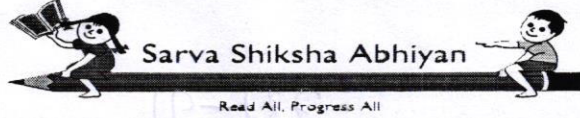

**ORDER**

*Ms Moryom Ngupok* D/o Late Osup Ngupok is hereby engaged as **Part Time Instructor** (PTI) Work Education on Contract basis in the fixed pay of **Rs. 12809/- (Rupees twelve thousand eight hundred nine)** only as per state office approved for appointment of PTI Vide Order No.AR/SSA/PEDA-MISC/2015-16, Dated Itanagar the 26<sup>th</sup> Sept'2017. His/her salary will be drawn w.e.f. the date of joining in the concerned school where he/she is posted for the academic session / contract period **2017 - 2018** against centrally sponsored scheme of **Sarva Siksha Abhiyan**. He/She is posted at **Govt. Upper Primary School Kangkong**.

**The engagement is subject to the following conditions:-**

1. The contract teacher / employee has no right to claim for regular appointment/regularization of the post after expiry of contract employment.
2. Except casual leave no other leave is admissible as per norms.
3. During contract service period he/she is not entitle of medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel for vacation period etc.
4. The second party shall be entitled for drawl of salary only for the academic session / contract period. Salaries for vacation period of teachers shall be drawn only when he/she is engaged in training, bridge course and any other departmental engagement.
5. His/Her service period will be counted from the date of joining in the duties.
6. He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract service.
7. The engaged Teacher is also to work as volunteer instructor for TLC Programme in the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
8. No representation will be accepted for change of posting place.
9. The engaged teacher will have to undergo DIET training at concerned DIET for training as a when call for.
10. The employee has to sign an agreement for contract engagement before receiving his/her engagement order.
11. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
