2. The appointment is subject the following conditions:-
 - a. The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month's notice. If he/she wishes to resign he/she will have to give one month's notice.
 - b. after joining duty, he/she will have to take an oath of allegiance or give affirmation to the constitution of India duly in the prescribed form before an officer.
 - c. He/she will have to produce a Medical Certificate from an authorised medical Officer to the effect that he/she is medically fit for the Govt. Service.
3. The appointment is subject to the police Verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the police report.
4. The other terms and conditions which are specified herein would be governed by the rules and orders that may be in force from time to time.
