ORDER

Shri/ Smt/ Miss TEJUNAM PERTIN is hereby engaged as Resource Teacher/ I.E. Volunteer on contract basis in the fixed pay of Rs. 11000/- (Rupees Eleven thousand) only with effect from the date of joining in the concerned district upto 20/10-11 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/ she is posted at BRC/CRC, Geera Mariyang.

The engagement is subject to the following conditions:-

- The Resource Teacher/ I.E. Volunteer has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditioned in the agreement copy.
