## //ORDER//

Shri Wangkhon Wangsa is hereby engaged as A/T on contractual basis and posted to Govt. Primary school, Laho Thinsa under Tirap District in the fixed pay of Rs 21,175/- (Rupees twenty one thousand one hundred seventy five) only with effect from the date of joining in the concerned district up to the academic session against centrally sponsored scheme of Sarva Siksha Abhiyan (SSA).

## The engagement is subject to the following conditions:

- 1) The contact teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- 2) No earned leave is permissible except casual leave as per Central Civil Leave Rule and as per terms and condition mentioned in the copy.
- 3) During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowance reimbursement of tution fees, leave travel concession (LTC) Special compensatory allowance etc.
- 4) The second party shall be entitled for drawal salary of only for academic session. Salaries for vacation period shall be drawn only when they are engaged in training, bridge course and any other departmental engagement.
- 5) The contract teacher have to report his/her duty at posting place within 7 ( seven ) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- 6) He/she is not entitled to subscribe GPF or CGEIS of such order scheme during the period of contract service.
- 7) The engaged teacher is also to work as volunteer/instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his /her normal duties.
- 8) He/she will have to undergo DIET training at concerned DIET for training as and when call for.
- 9) The order terms and conditions of the service which are not specified shall be governed by the relevant rules and order forced time to time.
- 10) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
