3. The mark sheets / Certificates and RCI number submitted by him/her for appointment are subject to verification from original source. In case of the forged Mark sheets/ Certificates, she will be punished as per rules.
4. No earned leaves shall be permissible except 12 days casual leaves as per CCS leave rule.
5. During the contract service period he/she will not be entitled for Medical reimbursement, children educational allowance, reimbursement of tuition fees, leave travel concessions(LTC), special compensatory allowance etc.
6. No representation will be accepted for change of posting place.
7. He/she will have to undergo for RP's training as and when call for.
8. The other terms and conditions of service which are not specific shall be governed by the relevant rules and order in force at time to time.
9. She will have to sign an agreement for contract engagement.
10. The incumbent shall report to the posting place within 7 days from the date receive of this order letter.
