- (b) After joining in the duty he/she shall have to take an

- (c) He/she will have to produce medical fitness Certificate
in prescribed form from an authorised medical officer.
- (d) The appointment is subject to Police Verification and
he/she will be dismissed from Govt. Service if any
adverse reports are there with immediate effect.
