//ORDER//

Ms. Meenakshi H. Lowang, APTET qualified is hereby engaged as Assistant Teacher on contractual basis under SA District Mission Tirap in the fixed pay of Rs. 21175/- (Rupees twenty one thousand one hundred seventy five) only with effect from the date of joining in the conferred posting place up to academic session against centrally sponsored cheme of Sarva Siksha Abbiyan. She is posted at *Govt Secondary School, Kapu* in Khonsa Block.

The engagement is subject to the tolic wing conditions:-

- The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual as per Central Civil Leave Rule and as per terms and condition
  mentioned in the copy.
- During contract service period he /she is not entitle for medical reimbursement, winter allowances, children
  éducational allowance reimbursement of tuition fees, leave travel concession (LTC) Special compensatory
  allowances etc.
- 4. The Second party shall be entitled for drawl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training. Bridge course and any other departmental engagement.
- 5 The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned ODSE, failing which his/ her engagement order will automatically be treated as cancelled.
- 6. He/She is not entitled to subscribe GPF or CGEIS of such order schemed during the period of contract service.
- 7. The engaged teacher is also to work . . volunteer instructor for TEC programme for the interest of literacy in Arunachal Pradesh in addition to his / incrinormal duties.
- 8. No representation will be accepted for change of posting place.
- 9. He /She will have to undergo DILT trooning at concern DILT for training as and when call for.
- 10 The order terms and condition of the ervice which are not specified shall be governed by the relevant rules and order forced time to time.
- If the engaged teacher has to sign an egreement for contract engagement before receiving this engagement order.
