ORDER

Miss Nima Dema Monoji is hereby engaged as Assistant Teacher on contract basis in the fixed pay of Rs. 21,175/- (Rupees Twenty One Thousand One Hundred Seventy Five) only with effect from the date of joining in the concerned district up to 31<sup>st</sup> March 2016 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. She is posted at Govt. Primary School Chillipam, under Kalaktang block.

**The engagement is subject to the following conditions:-**

- The contract teacher has not right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he/ she is not entitled for Medical Reimbursement; Winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
- The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- He/ she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his / her normal duties.
- No representation will be accepted for change of posting place.
- He/She will have to undergo DIET training at the concerned DIET for training as and when called for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- Joining shall be accepted from the 1<sup>st</sup> June'2015 on opening of new academic session upto 7<sup>th</sup> June'2015 failing which order shall be treated as cancelled.
