The above appointment are subject to the following conditions :-

- (a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one months notice from either side.
- (b) After joining duty he will have to take an oath of allegiance to give affirmation to the Constitution of India in the prescribed form.
- (c) He will have to produce a Medical Certificates from an authorised medical Officer to the effect that he is medically fit for the Government Service.
- (d) The appointment is subject to the Police Verification and he will be discharged from Service with immediate effect if there be any adverse remarks against his in the Police report.
- (e) The appointments are for a probation period of 2 (two) years. If the work and conduct of the teacher is not found satisfactory, he may be terminated.

The other terms and conditions which are not specified here in would be governed by the Rules and orders that may be in force from time to time.


