- (a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month notice from either side.
- (b) After joining duty he/she will have to take an oath of allegiance or give affirmation to the constitution of India in the prescribed form.
- (c) He/she will have to produce a Medical Certificate from an approved Medical Officer to the effect that he/she is medically fit for the Government service.
- (d) The appointment is subject to the Police Verification and he/she will be discharged from service with immediate effect if there be any adverse reports from the police officers.
- (e) The appointments are for a probation period of 2 (two) years. If the work and conduct of the person is not found satisfactory, he/she may be terminated.

The other terms and conditions which are not specified here in shall be governed by the Rules and orders which may be in force from time to time.
