- (d) The appointment is subject to the Police
Verification and he/she will be discharged
from service with immediate effect if there
be any adverse report from him/her in
the police report.
- (e) The appointment for a probation period
of 2 years. If the work and conduct of
the teacher is not found satisfactory, he/she
may be terminated.
