In pursuance of the Govt. approval vide U.O. No.4370 Dated 14/02/2020, Smti Rumi Khoisia Hakhun, TGT (ISSE) is hereby appointed as Trained Graduate Teacher (TGT) on Compassionate ground in the Pay Matrix of Pay Matrix Level-7- per month plus other allowances as admissible under rules from time to time with effect from the date she actually reports for duty at the disposal of DDSE, Khonsa, Tirap District.

The appointment shall be on Compassionate Ground as Govt. of India, Ministry of Home Affairs Order No. 1404/20/90 Estt. (D) dated 09/12/93 and Decision of the Cabinet dated 02<sup>nd</sup> Jun' 2019 under Para (g). The appointment is made against the resultant vacancy of Lt. Birendra Bhadur Singh, TGT, expired.

The appointment is made subject to the following conditions :-

1. *The appointment is on probation for a period of 02 (Two) years. During probationary period, his/her service may be terminated at any time without any notice or assigning any reason. The regularization of service will be considered on completion of probationary period subjected to satisfactory performance of duty.*
2. *After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.*
3. *The appointment is subjected to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.*
4. *After joining duty he/she will have to take oath an allegiance of affirmation to the Constitution of India in the prescribed form.*
5. *On joining, the appointee shall have to serve for a minimum period of 02 (Two) years at the place of posting.*
6. *The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at posting place.*

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
