- The seniority of the appointee shall be based strictly on their on merit list.
- 8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for charge of posting place or does not join within 30 (thirty) days from the date of issue of this order posting place.

The other terms and condition of service which are not specified here in shall be governed by the rules in force from time to time.
