Teacher(B) in the Scale of Pay of Rs.950 20-1150-EB-25-1500/-p.m. plus other allowances as admissible under rules from time to time on compassionate ground as per Govt. of India's Ministry of Home Affairs OM.No.14014/10/76- Estt(D) dated 25.5.77 and posted to East Siang District, Arunachal Pradesh with effect from the date she actually reports for duty to the Deputy Director of Public Instruction Pasighat.

The appointment has been made again the vacancy of Mapak Ratan, Asstt. Teacher retired.

The appointment is subject to the following conditions :-

- (a) The appointment is for 3(three) years only and further continuation will be considered after her passing B.A. from a recognised University.
- (b) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one months notice from either side.
- (c) After joining duty she will have to take an oath of allegiance of give affirmation to the Constitution of India duly in the prescribed form.
- (d) She will have to produce a Medical Certificate from an authorised medical officer to the effect that She is medically fit for the Government Service.
- (e) The incumbent is to pass BA within three years from the date of issue of the order other-wise her Services will be terminated as per standing instructions.

The appointment is subject to Police Verification and she will be discharged from Service with immediate effect if there be any adverse remarks against her in the Police report.

The other terms and conditions which are not specified here would be governed by the rule and order that may in force from time to time.
