## ORDER

In pursuance with vide Govt. order No. AR/SSA/BRC- 13/2017-18/ Dated Itanagar the 20<sup>th</sup> Sept 2017, Ms. Boni Measam is hereby appointed as **RP(science)** under the Head of Academic Support through BRCs/URC on contractual basis at the fixed pay of Rs. 26,453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only per month with effect from the date of joining. She is temporarily attached to Govt. Hr Sec. School, Jang till further order.

The engagement is subject to the following conditions:-

- Their contractual service is purely temporary and can be considered for continuation on the basis of performance and approval of salary in subsequent PAB.
- 2. They have no right to claim for regular appointment /regularization of the post after expiry on contract engagement.
- 3. The Marksheet/Certificates submitted by them for consideration are subject to verification from original source. In case of the forged Marksheet/Certificates they are liable to face legal action as per CCS Rule.
- 4. No earned leave is permissible except 12 days casual leave as per central civil service leave rule.
- 5. During contract service period they are not entitled for medical reimbursement, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowance etc..
- 6. They have to report for their duty at posting place within fifteen days, failing which their appointment order will automatically be treated as cancelled.
- 7. They are not entitled to subscribe GPF,CGEIS or such other schemes during the period of contract service.
- 8. No representation will be accepted for change of posting place.
- 9. The other terms and conditions of service which are not specified shall be governed by the relevant rules and order in forced time to time.
- 10. They have to sign an agreement for contractual service before receiving appointment order.
