Pr. C. Baruah S/T (Pol. Sc) appd. as H.M.)

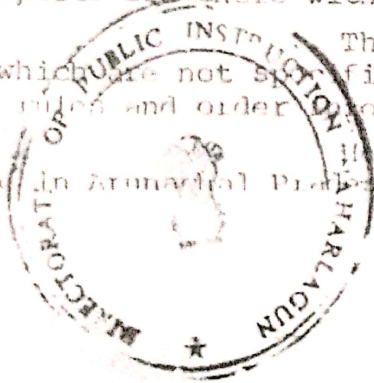
The Officer shall be on probation for

- (a) The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one month's notice. If he/she wants to resign may require to give one month's notice or surrender one month's salary.
- (b) After joining in the duty he/she shall have to take oath of allegiance of affirmation to the constitution of India in the prescribed form.
- (c) He/she will have to produce medical fitness certificates in prescribed form from an authorised medical Officer.
- (d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
