3. During contract service period he she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.

4. The Second Part shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge Course and any other departmental engagement.

8. No representation will be accepted for charge of posting place.

9. He/She will have to under gone DIET training at concern DIET for training as and when call for.

10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
