Miss Kapi Doni is hereby appointed as PTI (Art Education) on contractual basis against the Govt. Secondary School Pinewood , Khonsa of Tirap District and posted to Govt. Secondary School Pinewood , Khonsa in the fixed pay of Rs. 12,809/- (Rupees Twelve thousand eight hundred Nine) only with effect from the date of joining in the concerned school up to academic session 2019 20 , against centrally sponsored scheme of ISSE, Samagra Shiksha.

The appointment is subject to the following conditions:-


1. The appointment in contractual is purely temporary and contractual basis for session 2019-20.
2. The contractual employee has no right to claim for regular appointment / regularisation of the post after expiry of the contractual appointment.
3. No earned leave is permissible except casual leave as per Central Civil Leave (CSS) Rule.
4. During contract service period she is not entitled for medical reimbursement, winter allowance, children education allowance, reimbursement for tuition fee, Leave Travel Concession; special compensatory allowance etc.
5. The contract employee has to report her duty at posting place within 7 (seven) days from the date of appointment failing which her appointment order will automatically be treated as cancelled.
6. She is not entitled to subscribe GPF or CGEIS of such order scheme during the period of contract service.
7. The order terms and conditions of the service which are not specified shall be governed by the relevant rules and order forced from time to time.
8. The contract service shall be terminated by the undersigned on receipt of substantive complaint from the contractual Headmaster/SMC.
9. The PTI, Art Education has to sign an agreement for contract appointment before receiving this appointment order.
