//ORDER//

*Shri Ikar Doke* is hereby appointed as PTI (Art. Edn) on contractual basis and posted to Government Upper Primary School Bank Colony, Khonsa under Tirap District in a fixed pay of Rs. 12,809// (Twelve thousand eight hundred nine only) with effect from the date of joining in the concern district up to the academic session against centrally sponsored scheme of Sarva Siksha Abhiyan (SSA).

The appointment is subject to the following conditions:-

1. The PTI (Art. Education) has no right to claim for regular appointment/regularization of the post after expiry of contract agreement.
2. No earn leave is permissible except casual leave as per central civil leave rule and as per terms and conditions mention in the copy.
3. During contract service period he/she is not entitled for medical reimbursement, winter allowance, children education allowance, reimbursement of tuition fee, leave travel concession, special compensatory allowance etc.
4. The second party shall be entitled for drawl salary of only academic session. Salaries for vacation period shall be drawn only when they are engaged and training, bridge course and any other departmental engagement.
5. The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concern DDSE, failing which his/her appointment order will automatically be treated as cancelled.
6. He/she is not entitled to subscribe GPF or CGEIS of such order scheme during the period of contract service.
7. The order terms and condition of the service which are not specified shall be governed by the relevant rules and order forced time to time.
8. The PTI (Art. Education) has to sign and an Agreement for contract appointment before receiving this appointment order.


