**ORDER**

Miss Bagyansai Manyu, M.Sc is hereby engaged as **Trained Graduate Teacher (TGT)** on contract basis in the fixed pay of Rs.20, 000.00 (Rupees Twenty Thousand) only per month with effect from the date of Joining in the concern School. In fact, she is posted at Govt. Upper Primary School, **Bekhuliang**.

**The engagement is subject to the following conditions.**

- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- b) No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- c) 60 (Sixty) days Child Care Leave and 180 days maternity leave for female employees are entitled upto 2 (Two) Children in whole service period. The admissibility shall be minimum of 5 (Five) years of continuous service.
- d) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances and any other such allowances.
- e) The contract teacher has to report his/her duty at posting place within 7(seven) days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
- f) He/she is not entitled to subscribe GPF / CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any addition to his/ her normal duties.
- h) No representation will be accepted for change of posting place.
- i) He/she will have to under gone DIET training at concerned DIET for training as and when called for.
- j) The other terms and conditions of services which are not specified shall be governed by the Relevant rules /Orders / Guide lines / Instruction in force time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- l) His/her contractual service will remain valid only up to **31<sup>st</sup> March' 2024** and thereafter it will be treated automatically terminated and a **fresh renewal would be required on 1<sup>st</sup> week of April Month every year** for the next academic session subject to his/her performance.
- m) He / She will have to report for duty at his / her posting place within 7 (Seven) days positively. His / her Pay will be drawn only after getting joining report through the concerned School.
