2. The appointment shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His / her continuation beyond probation period for 2 (two) year shall be subjected to satisfactorily performance during probation period.

1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign, he / she may do so after giving one month notice or by surrendering one month salary.
