period.

conditions :-

- a) The appointment is purely temporary and may be terminated  
at any time without assigning any reasons. If he/she want  
to resign he may do so after giving one month's notice or  
by surrendering one month pay.
- b) After joining the duty he/she shall have to take an Oath  
of allegiance of affirmation to the constitutions of India  
in the prescribed form.
- c) He/she will have to produce Medical fitness Certificate  
in prescribed form from an authorised Medical Officer.
- d) The appointment is subject to Police Verification and he/  
she will be dismissed from Govt. Service if any adverse  
reports are there with immediate effect.
- e) The other terms and condition of services which are not  
specified herein, shall be governed by the relevant rules  
and order's in force from time to time.

terms in his present posting place.
