**ORDER**

- During contract service period he is not entitled for Medical Reimbursement, Winter Allowance, Children Education Allowance, Reimbursement of tuition fees, Leave Travel Concession, Special Compensatory Allowances etc.
- The contract employee is not entitled to subscribe GPF / CGEIS or such other schemes during the period of contract service.
- No representation shall be accepted for change of place of posting.
- He will undergo DIET training at DIET Dirang as and when called for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules from time to time.
- The engaged teacher shall have to sign a deed of agreement for contract engagement before receiving this engagement order.
