WAPPOINTMENT ORDER!

Shri Holai Wangsa is hereby engaged as Part Time Instructor (Work Education)) on a contract basis in the fixed pay of Rs. 12,809/- (Rupees Twelve Thousand Eight Handred Nine) only per month with effect from the date of joining in the concerned School for a period of one year against resultant vacancy under Centrally Sponsored Scheme of Samagra Shiksha/ISSE. He is posted at Covil Primary School, Voton under Pongchan Block.

The engagement is subject to the following conditions: -

- This engagement is made subject to Administrative approval of SPD, Samagra Shiksha/ISSE, Itanagar vide file No. SS-11011/40/2021-O/o SPD, SAMAGRA SHIKSHA.
- The Contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- 3. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- 4. If the incumbent remains absent, no Pay will be paid for the absent periods.
- 5. In case, the appointee is found not staying in his her place of posting and not sincere in his/her duty, his/her Contract Service will be terminated at any time by the DPD, ISSE Longding.
- 6. At the end of the contract Agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
- During contract service period he/she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.
