Shri/Smti/~~Miss~~ **Toilem Josaham** is hereby appointed as **Part Time Teacher** on contractual basis in the fixed pay of **Rs.5000/- ( Rupees Five Thousand )** only with effect from the date of joining in the concern posting place against centrally sponsored scheme of Sarva Shiksha Abhiyan.He/She is posted at **Govt. Residential School Pongsen under Pongchau Block** Longding district. The appointment is subject to the following conditions:-

- 1) The contractual services have no right to claim for regular appointment/ regularization of the post after expiry of contract appointment.
- 2) No earn leave is permissible except casual leave as per central civil service rule and as per terms and conditions
- 3) During contractual service period he/she is not entitle for medical re-imbusement, Winter Allowances, Children's Education Allowances, re-imbusement of Tuition fees, Leave Travel Concession (LTC ) Special Compensatory Allowance etc.
- 4) The contractual service have to report His/Her duty at posting place within 7 (seven) days from the date of joining the office of District Project officer, Longding. Failing which His/her appointment order will be automatically be treated as cancelled.
- 5) He/ she is not entitled to subscribe GPF or CGEGIS or such other schemes during the period of contract service.
- 6) The appointed contractual service is also to work as volunteer instructor for TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to His/her normal duties.
- 7) No representation will be accepted for the changing of posting place.
- 8) The other terms and conditions of the service which are not specified shall be governed by the relevant rules and order enforce in time to time.
