ORDER

In pursuance of Govt. approval vide U.O. No. Nil dated 3/3/2008, the service of Smti Chissilly Dolley is hereby regularized temporarily to officiate as Assistant Teacher(A) in the scale of pay of Rs.4500-125-7000/- p.m. plus other allowances as admissible under rules from time to time with effect from he/she actually reports for duty to the DDSE, Pasighat, East Siang District, Arunachal Pradesh. He/She is appointed against Smti Pakter Koyu, AT(A) promoted to J/T.

The appointee shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His/her continuation in service beyond probation periods for 2 (two) years is subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:-

- a) The appointment is purely temporary and will be terminated with 1 (one) month notice. If he/she wants to resign he/she may do so after giving 1 (one) month notice or by surrendering 1(one) month salary.
- b) The continuation of service will be subject to satisfactory performance of duty during probation period.
- c) After joining he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) ~~The appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if any adverse report is there with immediate effect.~~

The terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
