ORDER

Shri. Tami Apang is hereby engaged as Information and Communication Technology-Instructor @ Secondary level on contractual basis for session 2023-24 on the merit of waiting list against the post vacant by Shri. Dhiraj Kumar, under ISSE Samagra Shiksha District Society, East Siang District in the fixed pay of Rs 15,000/- (Rupees Fifteen Thousand) only with effect from the date of joining in the concerned school.

He is posted at KGBV School, Yagrung.

The engagement is subject to the following conditions:-

1. The contract ICT-Instructor has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
2. No Earned Leave is permissible except casual leave as per Central Civil Service Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period he/ she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
4. The contract ICT-Instructor have to report his/ her duty at posting place within 07 (Seven) days from the date of joining in the office of concerned school, failing which his/ her appointment order will be treated as cancelled.
5. He/ She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
6. The Engaged ICT-Instructor is also to work as volunteer instructor for TLC programme for the interest of Literacy in Arunachal Pradesh in addition to his/ her normal duties.
7. No representation will be accepted for change of posting place.
8. He/ She will have to undergo Induction/Orientation/DIET training at concern DIET or any other venue specified by department concerned for training as and when call for.
9. The continuation and extension of the services of the Engaged/appointed ICT-Instructor contract at the end of a financial year shall be subject to the approval of the continuation of the Project (Samagra Shiksha) under digital initiatives, by MoE, Govt. of India and the subsequent extension period will be subject to Satisfactory Performance of duty.
10. The Engaged ICT-Instructor shall be on the basis of 'No work No Pay', Salaries shall be paid only for the academic session. No salary will be paid for vacation period.
11. The Engaged ICT-Instructor has to sign an agreement for contract engagement before receiving this engagement order.
12. The other terms and conditions of services which are not specified shall be governed by the rules and guidelines issued and enforced by the Central/State Govt. from time to time for contractual staffs.
