**ORDER**

*Shri Taba Abu is hereby appointed as Trained Graduate Teacher (TGT) on compassionate ground in the Pay Matrix Level -7, Cell- I Basic Pay Rs. 44,000/- per month Plus other allowances as admissible under rules from time to time. He is posted at Govt. Upper Primary School Taksing, Taksing Circle under the disposal of DDSE, Daporijo, Upper Subansiri District (A.P).*

The compassionate appointment is made against the vacant post of Shri Suresh Kr. Asthana, TGT (Retired).

The appointment is made subject to the following conditions:-

1. The appointment may be terminated at any time by giving 1(one) month notice. If he/she wants to resigns, he/she may do so after giving one month notice or by surrendering one month salary.
2. After joining duty He/she will have to produce medical fitness certificate from an authorized medical officer.
3. The appointment is subject to police verification and he/she will be dismissed from service with immediate effect if there is an adverse remark against him/her in police verification.
4. After joining duty he/she will have to take oath of an allegiance of affirmation to the constitution of India in the prescribed form.
5. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
6. The seniority of the appointee shall be based strictly on their date of joining.
7. He/She should join within 30 (thirty) days from the date of issue of this order.

The other terms and conditions of service which are not specified herein shall be governed by the rules in force from time to time.
