3. *The appointment is subject to police verification and he/she will be dismissed from service with immediate effect if there is an adverse remark against him/her in police verification.*
4. *After joining duty he/she will have to take oath of an allegiance of affirmation to the constitution of India in the prescribed form.*
5. *On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.*
6. *The seniority of the appointee shall be based strictly on their date of joining.*
7. *He/She should join within 30 (thirty) days from the date of issue of this order.*
