The Appointment is subject to the following conditions:-

- The salary will be drawn from the date of his/her joining in the duty.

- 10. On their appointment as Primary Teacher (PRT) they should undergo compulsory in-service course of DPE/D.El.Ed within 3 (three) years failing which their appointment order shall be cancelled.
