**APPOINTMENT ORDER**

Miss Binita Ngomle of Village Lebri, Upper Subansiri District (A.P), is hereby engaged as Trained Graduate Teacher(TGT) on contract basis in the fixed monthly salary of Rs.20,000/-(Twenty Thousand)only for the periods upto 31/03/2024 with immediate effect from the date of joining in the concerned school under the centrally sponsored scheme of Samagra shiksha/ISSE. He/She is posted at Govt. ....*Pry. School, Lebri, Nari*..... under *Daporijo*..... Education Block of Upper Subansiri District.

The Engagement has made against district existing vacancy as per Administrative approval vide No.SS-11011/37/201-O/O SPD-SAMAGRA SHIKSHA, Dated Itanagar the 5th June'2023.

**The Engagement is subject to the following conditions:-**

1. The contract teacher has no right to claim for regular appointment /Regularisation of the post after expiry of contractual Engagement.
2. No Earned leave is permissible except casual leave as per Central Civil Service Rule, and as per terms and conditions mentioned in the agreement copy.
3. During contract service periods ,he / she is not entitled for medical reimbursement, winter allowance, children education allowance, reimbursement of tuition fees, LTC, Special compensatory allowances etc.
4. The Contract teachers have to report his/her posting place within 7 (Seven) days from the date of issuance of the Order, failing which his/her engagement order will automatically be stand cancelled.
5. He/ She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
6. No representations shall be accepted for change of posting place.
7. He /She will have to undergo for DIET Training at DIET as and when call for.
8. Validity periods of contractual service is upto 31/03/2024, which may be extended by seeing the performance/ regularity of teacher and extension of the Project by MoE, Gol.
9. Other terms & conditions of service, which is not specified here, shall be governed by the relevant rules and order enforced time to time.
10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
