**ORDER**

Mrs. Mabak Naying, W/O Shri Mabak Tei is hereby engaged as **PRIMARY TEACHER (PRT)**, on Contract basis under Samagra Shiksha/ISSE vide approval letter no. No.SS-11011/36/2022-O/o SPD-SAMAGRA SHIKSHA-1/189713/2023 Dated 16<sup>th</sup> December 2023 in the fixed pay of Rs.15000/- (Rupees Fifteen Thousand) only per month with effect from the date of joining in the posting place up to 31<sup>st</sup> March 2024. She is posted at **Government Middle School, Raga-I** under Raga Block against the resultant vacancy of **Miss Yani Don, PRT** who has been resigned from the mentioned Post.

The engagement is subject to the following condition:-

1. The engage PRT has no right to claim for regular appointment/regularization of the post after the expiry of contract engagement period.
2. No earned leaves is permissible except Casual leave as per the central Civil Service leave rule and as per terms and the condition mention in the agreement copy.
3. During the contractual Service period she is not entitle for medical reimbursement, Winter Allowances, Children Education Allowances, Reimbursement of Tuition Fees, Leave Travel Concession, Special Compensatory Allowance etc.;
4. The contract Teacher have to join her duty place within 7 (seven) days from date of issue of appointment order, failing which her engagement order will be automatically treated as cancelled.
5. She is not entitle to subscribed GPF or CGEIS or such other schemes during the period of contract service.
6. If the incumbent remain absent, no pay will be paid for the absent period.
7. In case, the appointee is found absent in her place of posting and not sincere in her duty, her contractual service will be terminated at any time by the ISSE Director/ authority.
8. At the end of the agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
9. No representation shall be accepted for change of posting places.
10. She will have to undergo an Induction Training and Orientation Programs organize by the SPD Office as and when call for.
11. The engaged PRT has to sign an agreement for contract engagement.
12. The order terms & condition which are not specified herein shall be governed by the relevant rules and orders in force issued by the Samagra Shiksha/ISSE Arunachal Pradesh from time to time.




