ORDER

Shri Rakesh Kumar Sharan, Son of Late D.K.Sharan, Ex- teacher Menga I.V.School, Upper Subansiri District is hereby appointed temporarily to officiate as Asstt. Teacher(A) in the Scale of pay of B. 1200-30-1560-EB-40-2040/- per month plus other allowances as admissible under rules from time to time on compassionate ground as per Govt. of India's Ministry of Home Affairs OM No.14014/10/76-Estt(D) dt.25-05-77 and posted to East Kameng District, Arunachal Pradesh with effect from the date he actually reports for duty to the Deputy Director of Public Instruction, Seppa, East Kameng District, Arunachal Pradesh.

The appointment has been made against the vacant post of A/T(A).

The appointment is subject to the following conditions :-

- (a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month notice from either side.
- (b) After joining duty he will have to take an oath of allegiance of give affirmation to the Consitution of India duly in the prescribed form.
- (c) He will have to produce a Medical Certificate from an authorised medical officer to the effect that he is medically fit for the Govt. Service.

The appointment is subject to the verification and he will be discharged from Service with immediate effect if there be any adverse remarks against his in the police report.

The other terms and conditions which are not specified here would be governed by the rule and order that may in force from time to time.
