

### ORDER

Miss. Sila Shrestha is hereby engaged as Trained Graduate Teacher on contract basis in the fixed pay of Rs. 26453/- (Rupees Twenty Six Thousand Four hundred fifty three) only with effect from the date of joining in the concerned School of the district up to 31<sup>st</sup> March'2019 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. She is posted at Govt. Upper Primary School, Membachur.

The engagement is subject to the following conditions:-

- a. The contract teacher has not right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- b. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c. During contract service period he/ she is not entitled for Medical Reimbursement, Winter allowance, children educational allowance, reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
- d. The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e. She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- f. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to her normal duties.
- g. No representation will be accepted for change of posting place.
- h. She will have to undergo DIET training at the concerned DIET for training as and when called for.
- i. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
