**ORDER**

Shri/Miss/Smti Neelam Naju Toka is hereby engaged as Junior Teacher on contract basis under SSA in the fixed pay of Rs. 8307/- (Rupees Eight thousand three hundred only) with effect from the date of joining in the concern district for a period of 1(one) year. He/She is posted at Govt. Ariddle School Yajuli against PAB 2008-09/ Back-log.

The engagement is subjected to the following conditions:-

1. The contract Teacher has not right to claim for regular appointment/regularization of the post after expiry of contract appointment.
2. No earned leave is permissible except casual leave as per Central Civil service leave Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
4. The contract Teacher have to report his/her duty at posting place within 7(seven) days from the date of issue of this order for joining in the concerned DPO failing which his/her engagement order will automatically be treated as cancelled.
5. He/She is not entitle to subscribed GPF or CGIES or such other schemes during the period of contract services.
6. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
7. No representation will be accepted for change of posting place.
8. He/She will have to under gone DIET training at Yachuli when call for DIET training at Yachuli/Yajuli (Ref 08-09-2009)
9. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
10. The engaged teacher has to sign and agreement for contract engagement before receiving this appointment order.


