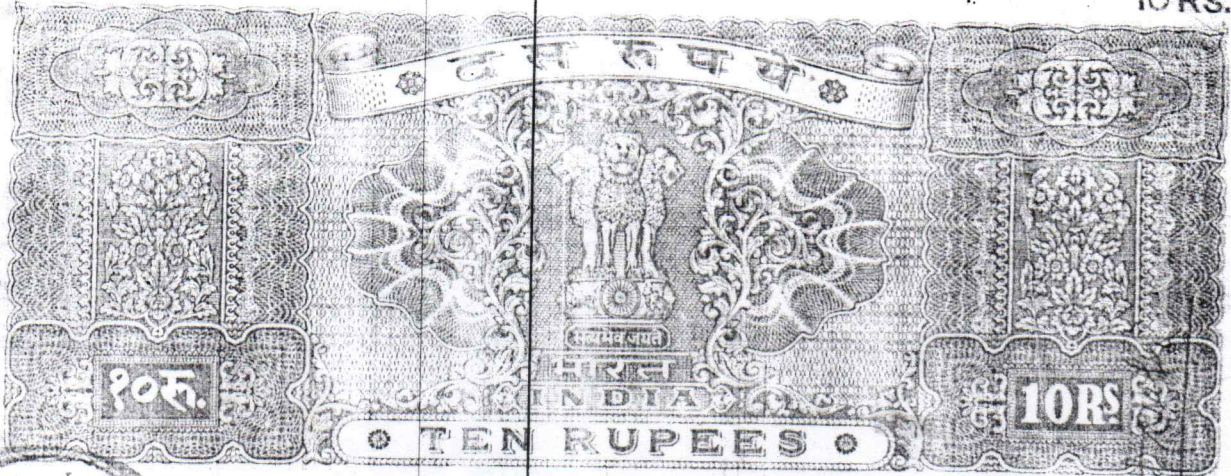

AFFIDAVIT

I, Mr. Takut Dabi, s/o Late Mr. Tama Dabi, aged approximately 48 years, permanent resident of Namey Village, P.O. Nari, District East Siang, Arunachal Pradesh and working as a JT, Government of Arunachal Pradesh and at present posted in Government Gandhi Middle School, Pasighat, P.O. Pasighat, District East Siang, Arunachal Pradesh do hereby solemnly affirm and declare as under:

- 1) That I am the real (biological) father of Ms. Passang Lhamu Meyor who was born on 16th March 1985.
- 2) Since I did not marry the mother namely Ms. Tshering Tsomo Meyor, both me and Ms. Tshering Tsomo Meyor amicably decided that our daughter will, till she attains 18 years of age, be staying with her mother and thereafter with me. Later on Ms. Tshering Tsomo Meyor married one Mr. Wangdup Meyor and hence my daughter started writing her stepfathers surname.
- 3) That therefore because of the above mentioned circumstances my daughter stayed with her mother till date and has subsequently returned to Pasighat under my care and protection.
- 4) That hence my daughters name in her class X and Class XII certificates carries her stepfathers surname and also her fathers name is given as Mr. Wangdup Meyor although I am the real father.
- 5) That my daughter Ms. Passang Lhamu Meyor was issued a Scheduled Tribe Certificate as Ms. Passang Meyor Dabi on 1.5.2001 by the Deputy Commissioner, Pasighat.
