

3. He / she will have to produce Medical fitness certificate in prescribed form an authorized Medical Officer.
4. The appointment is subject to Police Verification and he/ she will be dismissed from Govt. service if any adverse reports are there with immediate effect.
5. The other terms & condition of service which are not specified herein shall be governed by the relevant rules and order's inforce from time to time.
6. Miss Jaya Geyi shall have to continue for minimum tenure of 3 (three) years terms in his present posting place.




