

3. The other terms and conditions which are not specified herein would be governed by the rules and orders that may in force from time to time.

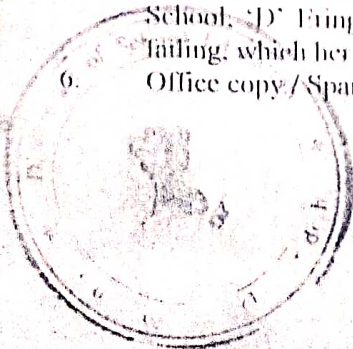
