She is posted at Govt Residential School Kararame

The engagement is subject to the following conditions:-

- This contract service shall be for the academic session 2014-15 commencing from the date of joining at the place of posting and ending at the end of academic session.
- b. The appointment is purely on temporary & contractual basis for the session 2014-15 only based on running of Residential School.
- The contract employee has not right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- d. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
