ORDER

In pursuance of the Govt. approval vide U/O No.234 dated 29/08/2011, the officiating services of Shri Tarak Talum, is hereby regularized to the post of Wood Work Teacher(WWT) in the pay scale of PB-2 Rs. 9300-34800 + GP-4200/- PM plus other allowances as admissible under Rules from time to time with effect from date of he /she actually reports for duties to the Principal, Govt. Hr. Sec. School, Palin, Kurung Kumey District. The regularization is made vice Shri Kamal Baruah, Ex-WWT, expired.

2. The appointment is made subject to the following conditions: -

- a. The appointment is purely temporary and may be terminated at any time without assigning any reason after serving one month notice. If she wants to resign may require to give one month notice or surrender one month salary.
- b. After joining in the duty she shall have to take an Oath of allegiance of affirmation in the constitution of India in the prescribed form.
- c. She will have to produce medical fitness certificate in the prescribed format from an authorized Medical Officer.
- d. The appointment is subject to Police Verification and she will be dismissed from Govt. service if any adverse reports are there with immediate effect.

3. The other terms and conditions which are not specified herein shall be governed by the relevant rules and order that may enforce from time to time.


